Ingredients: Water, croutons [enriched flour (wheat flour, malt barley flour, niacin, reduced iron, thiamin mononitrate, riboflavin, folic acid), canola and/or sunflower oil (with rosemary extract and ascorbic acid to preserve freshness), salt, maltodextrin, sugar, 2 % or less of yeast, whey, dextrose, garlic powder, buttermilk, onion powder, dehydrated parsley, natural butter flavor [with butter (cream, nonfat millk, salt), cream], corn syrup solids, guar gum, extractives of annatto and turmeric (color), enzymes, ascorbic acid], cranberries (sweetened dried cranberries, sugar, sunflower oil), butter (milk, cream, salt), breading (unbleached wheat flour, natural cane sugar, yeast, sea salt), celery, apple juice (from concentrate), onions, dehydrated vinegar, garlic powder, poultry seasoning (rosemary, oregano, sage, ginger, marjoram, thyme, pepper), sorbic acid, parsley and turmeric
